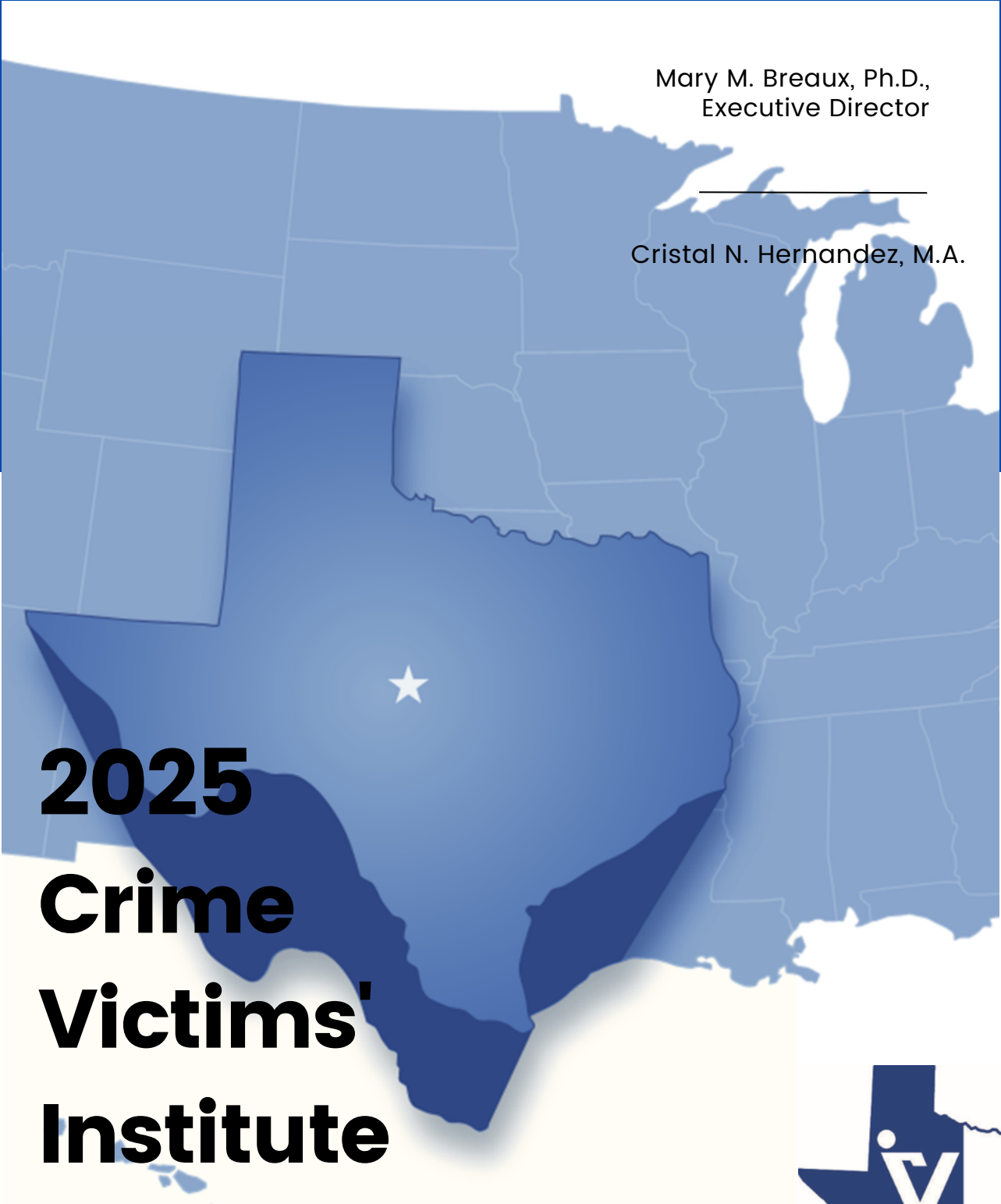

2025 Crime Victims' Institute Dashboard



What is the 2025 Texas Dashboard?

The 2025 Texas Dashboard provides a broad collection of key indicators of victimization in Texas during the past year. The Dashboard includes reported victimization incidents, the scope of service utilization from various government and non-government resource providers, offender accountability, and results from victimization surveys. The presentation of these statistics allows for monitoring trends, strengthens intervention policies and practices, and informs the implementation of prevention tactics. Additionally, the Dashboard assists with amending existing programs and policies, allowing for adopting practices better suited to reduce and ultimately end victimization and assist victims and survivors.

INDICATORS OF VICTIMIZATION IN TEXAS

Official reports of crime, utilization of services, and reports to law enforcement are lower than actual incident rates, particularly when considering highly personal victimization experiences, such as intimate, family, and sexual violence. Victims may be apprehensive about reporting their experiences for numerous reasons, such as fear of reprisal, financial dependence on the offender, or fear related to the criminal justice process. It is important to remember that the numbers below reflect only those incidents reported to formal agencies and that a substantial amount of victimization goes unrecognized.

TRENDS AND NATIONAL COMPARISONS

CVI's 2025 Dashboard provides current data for 2024 for comparison to the same indicators in 2023. Starting or baseline data from 2010 have also been included as a reference. Percent change is a calculation of the increase or decrease in a particular indicator relative to the previous year (2024 see formula below). Percent change is not the absolute difference in percent and may or may not be statistically significant since some change randomly occurs from year to year. For some indicators, national comparisons can also be made (see formula).

Reports of Harm (Child and Youth)

- The number of confirmed child physical abuse incidents have decreased by 6.04% from 2023 to 2024, while child sexual abuse incidents have decreased by 18.36%.
- The confirmed child abuse/neglect-related fatalities have decreased by almost 40% from 2023 to 2024.

Adult and Elder Victimization

- Validated investigations of abuse of elders slightly increased by roughly 4% from 2023 to 2024, and the adult maltreatment rate per 1,000 adults remained constant during the same time frame.
- The number of reported female victims of intimate partner homicide decreased by 23.46% from 2023 to 2024.

Reports to Law Enforcement

- The number of forcible rape incidents reported to law enforcement decreased by 1.09%.
- The number of sexual assault incidents reported to law enforcement was 12.63% higher, and family violence incidents reported to law enforcement was 0.87% lower in 2024.
- The number of reported hate crime incidents increased by 8.54% from 2023 to 2024.
- 526 human trafficking incidents were reported to law enforcement in 2023 and 408 incidents in 2024—a 22.43% decrease.

Utilization of Services

- It is important to note that data efforts used to comprise the statistics for the reported number of adults and children sheltered have differed since 2016. The new statistics reflect an estimate of the number of adults and children sheltered that year, and the average number of hotline calls answered that year in Texas based on a sample the National Network to End Domestic Violence collected over a 24-hour period during 2024.
- The average number of hotline calls answered increased by 6.82% from 2023 to 2024.
- Shelter services provided to children and adults increased by 41.25% from 2023 to 2024.

Offender Accountability

- The percent of family violence assault cases and sexual assault cases with convictions decreased in 2024, but forcible rape clearance and child sexual assault cases with convictions increased.

Note: Few of the data sources on the CVI Texas Dashboard are available nationally or in other states for comparison purposes. When they are available, data is rarely directly comparable. In particular, different states may have different definitions for family violence, maltreatment, domestic violence, rape, and sexual assault; different reporting requirements for child and elder abuse, and different crime classifications. Additionally, comparing incident counts across states is not advised due to differences in population size.
