Prison Victimization Webinar

On March 30, 2022, the Crime Victims' Institute and Department of Victim Studies at Sam Houston State University (SHSU) hosted a free webinar to discuss victimization in prisons. Mark Holmes, a representative of the Texas Restorative Justice Ministry Network, spoke on areas of sexual victimization within the criminal justice correctional system, methods that the Texas Department of Criminal Justice (TDCJ) utilizes to treat prison victimization inflicted on correctional clients, and incarcerated persons who were victimized before entering the correctional system. Kelli Wright-Nelson, Director of the Crisis Center of Matagorda and Wharton Counties, explained the types of advocacy services offered to people who are incarcerated, Prison Rape Elimination Act (PREA) standards, and how crisis centers can help prisons meet PREA standards. Dr. Breanna Boppre, an Assistant Professor in the Department of Victim Studies at SHSU, discussed the victimization of women, youth, and LGBTQ+ individuals. Dr. Jared Dmello, an Assistant Professor in the Department of Criminal Justice and Criminology at SHSU, covered gang victimization and the overlap between prison gangs and street gangs. Each of our speakers were well-versed and knowledgeable in their areas of study and practice. The webinar was attended by students, professors, victim service professionals, and law enforcement officers, and we received fantastic feedback! Sexual Assault Awareness Month Events

In recognition of Sexual Assault Awareness Month (SAAM), the Department of Victim Studies at Sam Houston State University (SHSU), the CVI, and various student and community organizations will host community-engaging events to assist survivors. It is our hope that these events raise awareness for sexual violence victimization and the diversity in survivors. First, on April 6, 2022, there will be a Campus Sexual Assault Panel at 2:00pm in the Courtroom of the College of Criminal Justice at SHSU. Speakers will include our Research Coordinator, Dr. Katie Ratajczak, representatives from Montgomery County Women's Center, Harris County Sheriff's Office, SAAFE House, and a doctoral candidate from the Department of Criminal Justice and Criminology at SHSU. On April 11, 2022, we will host Painting with a Purpose, an event in which the community, students, and survivors will be invited to



paint. The artwork can be kept by the artist or sold as a fundraiser for SAAFE House, a local sexual assault and domestic violence resource center. From April 27 to April 29, 2022, the Crime Victim Services Alliance at SHSU will host Denim Days to exhibit jeans with messages and stories of sexual assault survivors. These jeans will be displayed on the Lowman Student Center Yard at SHSU. We are grateful for everyone who has come together to make these events possible!
