Published by The Crime Victims' Institute College of Criminal Justice Sam Houston State University The Crime Victims' Institute (CVI) is excited to collaborate with a team of scholars to conduct research in various areas of victimization. All of the scholars are Sam Houston State University, College of Criminal Justice professors and students.

Dr. Peter Lehmann, an Assistant Professor in the Department of Criminal Justice and Criminology, with Dr. Andia Azimi will examine the link between youths' experiences with punitive school discipline in adolescence (e.g., out-of-school suspension, expulsion) and an increased risk of victimization in adulthood. Their analysis will assess whether this relationship is explained by (a) stable underlying personality traits, (b) the consequences of involvement in criminal activity via the "school-to-prison pipeline," or (c) long-term economic marginalization resulting from educational exclusion.

Dr. Elisa Toman is an Assistant Professor in the Department of Criminal Justice and Criminology. Her research will examine linkages between "green" victimization and the prison construction boom of the 1970s through the 2000s. Due to their size and associated industry, prisons can impact the environmental conditions of their surrounding areas. In her study, Dr. Toman will examine the health status of communities that surround prisons before and after their construction.


Dr. Katie Ratajczak, an Assistant Professor in the Department of Victim Studies, and Anne Wingert, a PhD student in the Criminal Justice and Criminology program, recognize how trauma-informed care is a standard practice in health and victim service fields for working with individuals who have experienced trauma. A trauma-informed approach acknowledges the harm the individual has experienced, reduces future retraumatization, and empowers the individual. Their project identifies how trauma-informed care is used by different professionals who work with sexual assault survivors. They use interviews with advocates, healthcare workers, police, and Title IX professionals to examine their approach to work with survivors. Despite the distinct differences between their professional roles, they each are able to enact the principles of trauma-informed care in different ways.

Dr. Miltonette Craig, an Assistant Professor in the Department of Criminal Justice and Criminology, acknowledges intimate partner violence (IPV) is a serious public health issue for female victims. Although IPV affects all groups of women, Black women face victimization at a disproportionately higher rate, and the effects of IPV are compounded when victims possess multiple marginalizing characteristics. The elevated risk of victimization for Black women has received broader media attention in recent years, and advocates contend that such media coverage must be comprehensive and accurate to effectively inform the public. Accordingly, this qualitative project examines news articles for their content in explaining the increased IPV risk faced by Black women.

Summer and Fall Events

The CVI participated in several conferences and events to learn more about the latest challenges, trends, and research regarding victimization. The Conference on Crimes Against Women in Dallas, Texas hosted sessions on a variety of topics relating to victimization of women, girls, and members of the LGBTQ+ communities. Conference attendees included criminal justice and victim services professionals (law enforcement officers, victim service providers, prosecutors, attorneys, medical professionals, etc.). The Texas Department of Family and Protective Services hosted the 2022 Light the Way Summit: End Human Trafficking in Dallas, Texas. This conference invited attendees to learn more about how labor and sex trafficking affects children and young adults, as well as learn how to better respond and work with survivors. The CVI Graduate Assistants had the opportunity to meet practitioners who worked for Child Protective Services, victim service agencies, and law enforcement agencies across Texas. In June, the CVI attended PRIDE in Houston, Texas, along with the Department of Victim Studies at Sam Houston State University (SHSU), to inform participants about victimization that happens to members of the LGBTQ+ communities.

On October 27th and 28th, 2022, in College Station, Texas, the Texas Victim Services Association (TVSA) will host their 2022 research symposium titled From Theory to Practice: Victimization, Justice, and Healing. This two-day event provides an opportunity for researchers and practitioners to discuss trauma-informed and survivor-centered practices and responses in different settings and disciplines.
