Second Annual CVI Conference

Our Mission

The mission of the Crime Victims' Institute is to:

- Conduct research to examine the impact of crime on victims of all ages in order to promote a better understanding of victimization.

- Inform victim-related policymaking at the state and local levels.

The Second Annual Crime Victims' Institute Conference, *Breaking Barriers: Advancing Research, Policy, and Advocacy for Crime Victims and Survivors*, was held at Sam Houston State University on October 15-17, 2025. Over 50 victim advocates and victim service professionals, law enforcement professionals, legal professionals, government officials, and academics/researchers from various district attorney's offices, police departments, sheriff's offices, juvenile justice departments, TDCJ, nonprofits, and universities all across the country were in attendance. Four CVI Advisory Board members were in attendance as well: Elizabeth Hamilton (Crime Victim Liaison, Texas Board of Pardons and Paroles), Heather Ayala (National Director of Victim Services, Mothers Against Drunk Driving), Forrest Mitchell (Retired Director of Operations, Nueces County Medical Examiner's Office), and Jeffery "JD" Robertson (Independent Consultant & Retired Major, Texas Rangers), in addition to Donald Stout from the Office of the Governor.

Attendees had the opportunity to learn from experts in the fields of Human Trafficking, Cybercrime Victimization, and Elder Abuse and Neglect, as well as network with one another. Upon the completion of all conference workshops and the keynote address, participants received a certificate of attendance. Attendees who completed an overall conference evaluation agreed that the conference was a valuable use of their time, well organized, and they would highly recommend it to others in their field. In fact, one attendee said, "I'm impressed. I learned a lot and made great connections." Another shared that, "All presenters were amazing. The information was relevant and clear, I love(d) the varying perspectives."

Based on the overwhelming positive feedback, and with the support of the CVI Advisory Board, the conference planning committee has decided to proceed with hosting the third annual CVI Conference. The 2026 CVI Conference will be held **October 14-16** at Sam Houston State University. 
Working with Survivors of Trauma and Trafficking: Legal and Mental Health Perspectives Webinar

CCAW 2026 – Call for Posters


