Responsible for uniform patrol operations in northwest unincorporated Harris County, Texas with a population of approximately 440,000. District One is a unique blend of grinding inner city poverty and crime as well as affluent, gated communities and consistently leads all other patrol districts in serious crime.

- Designed and planned the HCSO Decentralization Plan and implemented the pilot program in District One. This program uses the Intelligence Led Policing philosophy coupled with the Problem Oriented Policing operational strategy and brings uniform patrol, violent crime detectives and tactical enforcement groups together under a unified command structure. Integrated teams were formed with the Texas Department of Public Safety (state police), Houston Police Department as well as the FBI and BATFE. Early statistics show a significant decrease in robberies (± 38% individual; ± 28% Business) since program inception.
- Prior to the Pilot Program, above, implemented an Intelligence-Led Policing model which led to the formation of the Community Action Team (CAT). Using crime statistics, target areas/crimes were identified and the CAT Team was assigned to conduct multi-faceted operations to reduce or eliminate the problem(s). CAT Team operations led to decreases in four out of five "target crime" categories for which the Team was awarded a Meritorious Unit Citation.

- Community involvement led to nomination to the Board of Directors for the Houston Northwest Chamber of Commerce and assignment as the Chair, Grow Northwest Public Safety Committee.
- 2015–2016: Commander Task Force Division, Homeland Security Bureau Responsible for HCSO personnel attached to FBI, DEA, HIDTA, JTTF, ATF and USMS Task Forces as well as local, gang and juvenile intelligence operations.
- 2012–2014: Commander Criminal Warrants Division Planned, organized and conducted the division's first felony DWI warrant roundup to remove the most dangerous drivers from the road in preparation for the 2013 Memorial Day holiday; 125 of the targeted 200 wanted persons were captured. Instituted a tactical orientation due to divisional mission parameters. Redefined the job description and implemented new, more stringent transfer standards. Worked closely with line employees to build morale and set the acceptable standards for professional inter-action and conduct.
- 2010–2012: Commander Field Operations Division Completed development of the High Risk Operations Unit and merged it with the existing Bomb Squad. Oversaw grant funding for the purchase of a \$750,000 patrol boat for the Marine Unit. Responsible for the Office of Emergency Management personally interacted with petro-chemical industry, Port of Houston and U.S. Coast Guard officials regarding port security issues.
- 2001–2010: Commander 701 Jail, 1200 Jail and Administrative Services Divisions Reviewed and overhauled the complaint methodology, investigation and discipline process. Conducted and completed a staffing analysis and recommended major changes to the Table of Organization.
